Maine Farmers' Almanac for 1911 received from the publishers, Charles E. Nash & Son, Augusta, 10 cents by mail. There will be two eclipses, both of the sun, but neither visible in Maine. Lent begins March 1, Good Friday comes April 14 and Easter April 16. Ascension Day May 25. Christmas comes on Monday. The full moons occur:

at 5:47 evening January 14, February 13, 5:58 morning March 14. 7:19 evening April 13. 9:57 morning May 13, 1:30 morning June 11, 5:11 evening July 11, 8:14 morning August 9, 10:15 evening September 8, 11:17 morning October 7, 11:32 evening November 6, 11:9 morning December 5, 10:13 evening

Lodges should use these dates in making up their calendars, as Masonic Calendars from other states may vary enough to throw their meetings into another week and thus make them illegal. In 1910 the September full moon varied a day in our Illinois Calendar.

Bro. Ed. Quartier-la-Tente sends us the annual Masonic Universal Calendar for 1911. As we said last year it is a very full list of lodges in all the world except No. America, of which the states are given.

The Grand Council of Mississippi has voted to come under the General Grand Council. Also to have a report on correspondence, and E. George DeLap is appointed correspondent.

The Gr. Orient of Belgium has awarded to Robert Freke Gould the prize of \$800 for the best masonic book written in the last ten years, Gould's Concise History of Freemasonry.

The Grand Lodge of England has warranted King Solomon's Temple Lodge, No. 3464, which will be removed to Jerusalem after it is firmly established in London. Bro. R. F. Gould is a charter member. We wonder if it will illustrate speculative masonry as the Canadian-chartered lodge did.

The brethren will have been glad to learn that Past Grand Master Charles F. Johnson has been nominated to the U. S. Senate for the next six years. With him in the Senate and Past Grand Commander Frederick W. Plaisted as Governor, the craft of Maine is well represented.

The Grand Lodge of Delaware has voted that lodges hold jurisdiction over rejected candidates so long as they reside in Delaware, and resume it if they return without having been received elsewhere.

The Grand Orient of Belgium has founded a lodge at Stanleyville on the Congo River, Africa, making three in that valley, one French lodge at Brazzaville and one Italian lodge at Leopoldville.

Past Masters.—We have been asked if a Past Master can install officers before he has taken the degree of a Past Master. He can. His service makes him a Past Master. As the Grand Lodge recognizes the degree it is proper to enter his taking it on the records, but as it is not a part of the work of the lodge, it should be entered as a note below the record of the meeting.

Now we have got it we must cherish it, and see that too much of the burden of debt is not laid upon our successors.

### James Morrell Larrabee.

Judge James M. Larrabee, of Gardiner, died Monday afternoon, October 24th, aged 76 yrs. 10 mos. and 20 days. He was born in Wales, Maine, Dec. 4, 1833. He was long a teacher and held several municipal offices, until in 1885 he was appointed municipal judge, which office he held until his final illness, which was cancer of the liver. He married Priscilla Woodward of Winthrop in 1856, and had four sons, all masons, and one daughter.

He was initiated in Hermon Lodge in November, 1855, was Master in 1860, and was Senior Grand Warden in 1906, and was also Grand Representative from Alberta.

He was Grand High Priest in 1868 and was the eldest P. G. H. P, at the time of his death. He was Grand Representative from Louisiana in the Grand Chapter.

In the Order of High Priesthood he was the fourth from the head.

He was buried Oct. 28th, from the Congregational Church, with a Templar service by Maine Commandery.

#### Charles H. McLellan.

Charles H. McLellan, the senior past Grand Commander of Maine, died at Bath Oct. 23d, aged 81 years, 9 mos. and 23 days. He was born in Bath Dec. 31, 1828, and was an iron merchant. He spent seven years in California in the early days of gold mining and married Miss Marie Louise Kendrick of San Francisco. He left the wife, two daughters, Mrs. Emma F. Duncan of Bath and Mrs. Geo. F. Duncan of Portland, and one son, J. Henry McLellan of Port-

He was a fine musician, aud was prominent in musical circles.

He was a director in various enterprises and was a ship-owner.

He was a Past Master of Polar Star Lodge, was the senior past Commander of Dunlap Commandery, and was Grand Commander in 1869 and 1870. It was under his presidency that the field encampent was held at Cushing's Island and the dedication and review at Bangor.

He was a public-spirited and genial man and one who will be long remembered and missed.

### Samuel G. Davis

Died in Washington, D. C., Sept. 23d. He was a member of Mt. Moriah Lodge of Denmark, Oriental Chapter of Bridgton, and St. Alban Commandery of Portland. He was Junior Grand Warden of the Grand Lodge in 1888, and Grand Representative from South Carolina. For many years he had held an office in Washington.

Bro. Charles H. Alden of Waterville calls our attention to an article in the Token in October, 1871, expressing pleasure that the Eastern Star did not exist in Maine.

Forty years shows a wonderful difference and that Order is now very strong in Maine, and, as Bro. Alden says, does not seem to be doing any harm. In the smaller towns the ladies get up and serve the banquets, and their co-operation tends to make masonic gatherings society events, We have no doubt they increase the work of the lodges.

We have reason to believe that masons did not originally contemplate making masons of women, but the judicious management of the Eastern Star has resulted in its winning its way, and we are quite satisfied that it has come to stay.

Forty years ago we had a prejudice against Rob Morris, but later we came to know him personally and became very fond quite different in forty years, and is entitled to revise his opinions.

The new edition of the Grand Lodge Constitution has been completed and sent out, three copies to each lodge, one to each Gr. Officer and Permanent Member, and one to each Grand Lodge on our list. The cloth bound copy to each lodge is to be kept with the charter for formal occasions. Bro. Herbert Harris revised the edition, putting the amendments in where they belonged and inserting cross references, which with a new and fuller index will make it much easier for reference. It has been printed on extra heavy paper to stand more usage, and of duli finish so as to be more readable by artificial light.

#### Edwin Faxon Vose.

Bro. Edwin Faxon Vose died at his home in Portland January 13th, aged 60 years, 2 mos., 27 days. He was born iu Watertown, Mass., Oct. 17, 1850, and became a homeopathic physician.

He was a Past Master of Portland Lodge, Past High Priest of Mount Vernon Chapter, Past Master of Portland Council and Past Commander of Portland Commandery, a member of the High Priesthood and of the Scottish Rite bodies, the Shrine, Red Cross of Constantine and the Royal Order of Scotland. He left a wife and daughter. He was a genial and agreeable man and will be missed by a wide circle of friends.

RE-INSTATEMENT. - The question has been asked whether a member who was suspended for non-payment of dues and who died suspended, can be re-instated by the payment of the dues by a daughter who wishes to join the Eastern Star. As the question is likely to arise often, we answer it in the Token. It cannot be done.

While it would be desirable for the purpose of allowing the daughter to join the Eastern Star, it would open the way to admitting as perpetual pensioners widows and orphans who had lost thir special claims, by the simple payment of three or four dollars of back dues. They still have a modified claim on the fraternity, but not that strong claim which retained lodge membership gives.

The point was practically decided by Bro. Albro E. Chase when Grand Master. widow wished to pay a dollar or two to have her deceased husband's name re-entered on the Grand Lodge Register, when registering was allowed. She desired evidently to become a pensioner of the Charity Fund. Bro. Chase ordered that the money be refused.

The way the thing might work is shown by a case which happened before the five year limit was enacted.

changes entirely in seven years one must be | had allowed himself to be suspended twenty years before, found himself, while living in Massachusetts, afflicted with tuberculosis of the bowels. By wise advice he sent in the amount for which he was suspended and re-instated himself. Soon afterwards he called for assistance. The lodge, which was a small lodge down the coast, sent him \$10. He replied tartly that \$10 was a pretty sum to support a sick man and his family.

> It was a small sum for that purpose, but the lodge members were few and poor in purse, and they were entitled to judge if they would undertake the support of a family when he had ignored his own duties for twenty years to save the trifling dues, until he found himself incapacitated to work.

> The law of re-instatement came in by decision in the sixties and was afterwards incorporated in the constitution, but it was modified in 1900 by the five years' limit, to avoid the injustice of restoration for a mercenary purpose.

> RUGG MEMORIAL.—Grand Master Melish has started a fund for a monument and memorial to Past Grand Master Rugg, the surpuls to be given to the family. Although it is not permitted for Templars to address the Grand Master except through their Grand Commanders, we venture to say that a check or bills sent direct to the Grand Master will be cheerfully received and promptly acknowledged. We suggest that the commanderies and Sir Knights be ready to respond liberally when Grand Commander Philbrook brings the matter before them next May.

> STATISTICS.—Bro. Alexander B. Andrews, Jr., of Raleigh, N. C., sends us a copy of some admirable statistical tables which we should like to publish in full. We find that Maine has 40 masons to each 1000 of population, and 7 Templars. Vermont runs the highest for Templar percentage and Maine next. Louisiana is the lowest and North Carolina next. As the population includes women, children and colored people, such a comparison of course tells strongly against the southern people. We made a similar table in 1881, but found it a great labor. We appreciate the work Bro. Alexander has put into this and thank him for it.
